# **OUTDOOR SPA** MAINTENANCE KIT

#### **DESCRIPTION**

Complete kit of products for the integral treatment of outdoor spas and hottubs.

#### Consisting of:

- BROMOGENE: Brominated disinfectant in 20g tablets . (400g)
- ALGISIN: Liquid algaecide FOAM FREE. (500 ml)
- PLUS ACID: Granulated pH reducer. (500g)
- QUIMINET FORTE: Acidic cleaner for full or empty pools. (500 ml)
- **QUIMICAL PS:** Anti-fouling product. (500 ml)

#### **CHARACTERISTICS**

**Aspect:** Cardboard box containing 5 cans, dosing spoon,

thermometer and Bromine and pH analyser.

**Bromine** White pills of 20g.

#### **ACTIVE COMPONENTS**

**BROMOGENE:** Bromochloro-5,5-dimethylhydantoin 100% **ALGISIN:** Polymeric quaternary ammonium chloride (6.5-7.5%)

PLUS ACID: Sodium Bisulphate (100%)

QUIMINET FORTE: Phosphoric acid (7-8%) and non-ionic tensioactive agents (17-18%)

QUIMICAL PS: Sodium, potassium, acrylate, silicate, ester (22.5%)

## **INSTRUCTIONS FOR USE AND DOSAGE**

Always carry out the treatments when the SPA is not being used.

 BROMOGENE: 1 tablet every 1000-2000 litres of water daily. Keep the residual bromine between 1 and 3 ppm (mg/l). Do not apply directly in the spa, it is recommended that this is done in the skimmer or in a dosing device.

## **PRODUCT DATA SHEET**

- ALGISIN: 15 cm3 every 1000 litres per week. Add directly to the pool water.
- PLUS ACID: To lower the pH by a tenth, add 15 g per 1000 litres of water after dissolving in a bucket of water.
- **QUIMINET FORTE:** With the pool full or empty, pour a small amount into the pre-moistened sponge or pad and rub. Rinse with clean water without letting it dry out.
- **QUIMICAL PS:** Add directly to the water every time the spa water is changed (monthly) at a rate of 50-80 cm3 per 1000 litres. If partial refills are made, add the product proportionally.

These doses are indicative depending on the temperature, hours of sunshine, number of users, amount of organic matter in the water, etc.

### **APLICATIONS**

The purpose of this product is exclusive to the treatment of spa and hydromassage water, and it cannot be applied outside this area.

#### **FURTHER INFORMATION**

To avoid risks to people and the environment, follow the instructions for use. Do not mix the products.

Once the product is finished, rinse vigorously three times each container you use, pouring the washing water into the pool.

Empty containers must be deposited in points established by the local authority in accordance with their respective municipal ordinances. They must then be managed according to their hazardous characteristics and by authorised waste managers.
